



## FIRE REPORT BY STUART GREAVES

The Ministry of Natural Resources and Forestry confirmed a very quiet fire season in 2019, with only 44 fires in the Sudbury Area. Fortunately, only two of these fires were on Lake Panache:







#### Thank you to all campers for your diligence in fire control!

Please note LPCA replaced the old fire pump located at the Penage Bay Marina with a new unit that matches the other 9 units around the lake.

Your Campers Association has 10 Fire Pump Kits located around the lake. These kits contain a fire pump (runs on regular gas), 200' hose, a spray nozzle and suction line along with operating instructions. Please see the location co-ordinates on the next page or visit our website for the fire pump locations. The kits are for all to use in the event of a fire. It's very important to let any of the directors know if you used the kits or if there are any issues with the kits. Please return them the way you found them.

## A special "Shout Out" to thank all our volunteers who keep the fire pump kits at their camps; your dedication to this program is greatly appreciated!

Escaping for some summer fun requires the same amount of fire safety due diligence you use at home. Before you can truly relax and enjoy the great outdoors, you need to know your family is Fire Smart. That means working smoke alarms on every camp level and outside sleeping areas, make sure the batteries are fresh and alarms are within the manufacturer's specifications. Make sure your camp is equipped with CO detectors if you have a fireplace, woodstove, gas heater or any gas or propane appliances. Should a fire break out in your camp or surrounding area, please ensure your family has an escape plan and assembly area! Also, it's a good idea to have your camp GPS coordinates available should you have to call in a fire emergency!

Another great investment to your camp tool kit is your very own fire pump, hose and nozzle or consider sharing a system with your camp neighbours!

## LIGHT REPORT BY PAUL YOUNG

For many years, the Lake Panache Camper's Association has installed and maintained flashing amber shoal markers in the heavy traffic portions of the lake. Typically, we have the lights installed by the Victoria Day long weekend and removed sometime after Thanksgiving, dependent on weather and lake conditions. This work is done by volunteers who generously donate their time and resources to help us with this endeavour.

With the conversion to more reliable LED lighting a number of years ago, many markers are left out year round. This reduces the number of times we have to go out and service the lights as well as allowed some increased visibility for winter travel. Our ongoing improvements include changing some of the light stands, which have done their time and need replacement, and adding reflectors for increased daytime visibility.

Last spring, we had some damage caused by high water and shifting ice flows. Markers, which were never in the water at breakup in the past, were last spring. This required repairs and replacement. No new purchases were required as a few spares were purchased previously. More markers were removed last fall to prevent a reoccurrence.

If you come across a damaged or inoperable light in your travels, please e-mail info@lakepanachecampers.com so we can make repairs. It is a big lake and many do not venture too far at night. We rely on feedback from you to keep our lights flashing.

We remind all members and visitors to Lake Panache that our shoal markers are just that and not a legal navigational aid.

ORNGE classified our Air Ambulance Helipad for daytime use only and we continue to maintain the access road and site. Fortunately, ORNGE had no reason to use the site in 2019!

The City of Greater Sudbury introduced a "punch card system" system for those campers outside city limits (including Ojibway Road) wanting to use the Lake Panache Waste Transfer Depot on North Shore Road. Please see the LPCA website for details and the 2020 Transfer Depot hours of operation.

As we are all aware, mining, prospecting and mine reclamation is ongoing in the Sudbury Region. Your LPCA registered on the Environmental Registry website in order to receive any upcoming notices of mining related activities around Lake Panache. We will also post theses notices on the website and in our e-newsletter.

The Ministry of Natural Resources and Forestry (MNRF), Vermilion Forest Management (VFM) - Sudbury Forest, Northshore Forest Resource Management Advisory Committee and Northshore Forest Inc. (NFI) finalized their 2020 – 2030 Forest Management Plans for the forests around Lake Panache. Thank you to all who participated in the public consultation forums and for your input.

Our friends at Atikameksheng Anishnawbek are requesting our help to confirm sighting of the Northern Map Turtles in Lake Panache. Please report all sightings to Damien Mullin, Species-at-Risk Biologist at DMullin@WLFN.com. You can find further information on our website and click on Turtles.

Tim Walker and Paul and Nigelle Fredette head up our Lake Stewardship Committee and they do a fantastic job setting up an extensive water sampling and monitoring program. Their expertise in computers and recording produced some great Lake Stewardship videos and pictures available on our website; please take time to have a look! Please feel free to contact any of the directors with any questions, concerns or ideas you may have to enhance our water quality initiatives.

Your Lake Stewardship Committee held another successful Hazardous Waste Day on Saturday, July 13th, 2019 and two trailer loads of waste were taken away from our lake by the Toxic Taxi. Our 2020 Hazardous Waste Day is Saturday, July 11th, 2020, 8:00 A.M. to 12:00 Noon at the public dock. Please participate; it's free! All materials must be clearly identified as what they are when you drop them off.

## LAKE STEWARDSHIP REPORT BY TIM WALKER

On July 13th, 2019, the 7th annual household hazardous waste (HHW) event was held. Campers were encouraged to bring HHW to the air ambulance docking area where LPCA volunteers collected for pickup by the City's Toxic taxi for appropriate disposal.

HHW includes products such as paint, batteries, motor oil antifreeze and other items that cannot be disposed of in the garbage. This year, we managed to fill two trailers and redirect these items from the landfill. Please mark July 11th, 2020 on your calendar for the 8th annual event. All materials must be clearly identified as what they are when you drop them off. We hope to see you there.

In the meantime, please ensure your HHW is appropriately disposed of. Residents of the City of Greater Sudbury can call the Toxic Taxi (705-560-9019) to come to their property and pick up HHW or they can also drop off their waste at the depot on Frobisher Street on selected dates. Please check the City's website for more information about dates and what items qualify as hazardous waste (http://www.greatersudbury.ca/living/garbage-and-recycling/household-hazardous-waste/).

The Stewardship Committee conducted water sampling in Lake Panache in the summer of 2019. Both phosphorus and metals testing occurred. These tests are conducted on a biennial basis in order to establish an historical record of water quality in our lake. Samples are taken from 12 locations around the lake that take into account the size of the lake.

The Stewardship Committee uses sampling methods according to City of Greater Sudbury standards (including secchi disc and beta sampling equipment). The 2019 sampling season was the fourth such sampling. The Stewardship Committee continues to monitor these water quality indicators over the coming years and report back to the membership. Thank you to the City of Greater Sudbury for providing funding for this sampling through the Lake Stewardship Grant.

We are happy to report all metal and phosphorus sampling results from Lake Panache were found to be within the Provincial Water Quality Objectives (PWQO).

In addition, the presence of the invasive species - specifically the Spiny Waterflea - is of concern to LPCA. It is important to be vigilant in coming years regarding the presence of this invasive species. If you find Spiny Waterfleas or think you may have found Spiny Waterfleas in an area lake or water body, try to preserve the organism in rubbing alcohol. In conjunction with our community partners in the Greater Sudbury Watershed Alliance (GSWA), we want to share information about high salt levels in some city lakes, specifically Ramsey Lake. While this does not directly impact Lake Panache, this is an obvious concern to those who get their drinking water from Ramsey Lake.

Tap water samples from most locations collected around Ramsey Lake showed sodium levels of approximately 50 mg/L. When water systems contain sodium concentrations higher than 20 mg/L, the Medical Officer of Health must be advised. For persons with chronic diseases requiring a sodium-restricted diet, the intake of sodium from drinking water could be significant.

In addition, high chloride levels were measured close to 100 mg/L. These high levels of chloride could have a negative impact on aquatic life especially zooplankton and the resultant control of algae blooms.

These high salt levels are a result of the runoff of salt required to keep local roadways bare as required by provincial legislation and although the City of Greater Sudbury incorporated best practices in its Salt Management Plan, GSWA is concerned about protecting this ecosystem and important water supply and is taking a number of steps to further examine the research and inform citizens about these concerns.

## RURAL SEPTIC SYSTEM CHECKLIST

The Ministry of Agriculture, Food and Rural Affairs provides a rural septic system checklist with the following things to keep in mind:

- Regularly inspect your system and pump your tank as necessary
- Use water efficiently
- Don't flush hazardous chemicals or pharmaceuticals
- Plant only grass over and near your septic system. Tree roots can damage pipes
- Don't drive or park vehicles on any part of your septic system to avoid damage
- Test well water

If you're unable to deliver your household hazardous waste to the Household Hazardous Waste Depot, please call the Toxic Taxi answering service at 705-560-9019 to make an appointment for free home collection service.

Please leave your name and telephone number(s). Your call will be returned in 24 hours to schedule an appointment.

You may also make a Toxic Taxi appointment by email. Simply send an email to **Sudburytoxictaxi@hotzenvironmental.com** detailing your name, address and the waste you have to be collected. A representative will reply with an appointment date that you will be asked to confirm.

Please note for safety reasons, the Toxic Taxi will not pick up waste if you are not home.

### **Examples of materials accepted:**

#### Common examples of household hazardous waste include:

- medicines - household batteries - butane lighters and cylinders

- car wax - diesel - kerosene

- motor oil - antifreeze - windshield washer

paints - thinners - stains and preservatives

- rust removers - ammonia - aerosols

- glues - cements

- turpentine - paint strippers

- drain openers - oven cleaners

- fertilizers - syringes

### Materials not accepted:

No commercial, industrial, institutional, pathological, PCB, explosive, radioactive or unknown waste will be accepted. *Please note:* 

- All waste must be clearly labelled and in sealed containers.
- Reusable containers will not be returned (i.e. plastic gas cans).
- Do not mix different products together.
- Syringes must be in a puncture-proof container.
