#### Call to Order

#### **President's Report**

The President reported on the following activities:

- Repairs were completed to the dock in the marina on July 8 and 15; thank you to the volunteers who assisted with the repairs and to Pinehill Lumber for contributing \$500 towards the cost of the materials
- The lights at the helipad were vandalized in September 2022 and have not been replaced as they are not required; the helipad is approved for daytime use only
- The helipad was used on the Canada Day long weekend
- One small fire was reported in Sawmill Bay so far this summer
- The Association signed a new Memorandum of Understanding with the Ministry of Natural Resources and Forestry to continue to manage the property in the marina bay until 2035
- Preliminary work started on possible solutions to repair the breakwall in the marina bay

## **Treasurer's Report**

The Treasurer presented the financial statement for the fiscal year ending June 30, 20223

The Treasurer reported \$7,000 in revenue and \$6,500 in expenses.
